

TERMS & CONDITIONS

CAPIM Photography Competition 2022



By submitting an entry into the CAPIM Photography Competition 2022 ('Competition') held by the Centre for Anthropogenic Pollution Impact and Management you acknowledge and agree to the following terms and conditions:

1. Entry

- (a) The Competition is free to enter.
- (b) You must be 18 years or older to enter the 'Professional' or 'Novice' category and under 18 to enter the 'Junior' category. Competition.
- (c) You can submit a maximum of one entry to the Competition (each entry comprising up to three photographs). If multiple entries from you are received by CAPIM, only the first entry received first will be eligible for consideration.
- (d) Your photograph must be pollution related and have been taken in Australia.
- (e) The Competition commences 14 July 2022. You must submit your entry to CAPIM by 11.59pm AEST on Friday 30 September 2022. Late or lost entries will not be considered.
- (f) Your entry must include a completed online entry form, including uploaded photo(s), date of photo and caption.
- (g) You may be required to provide evidence to demonstrate your eligibility for the Competition.

2. Judging and prize money

- (a) A judging panel will be selected by CAPIM.
- (b) The judging panel will have complete discretion in assessing entries and allocation of prizes in each category. The judging panel reserves the right not to allocate an award in a particular category where, in its opinion, there are no entries of sufficient merit.
- (c) The decision of the panel is final, and no correspondence will be entered into.
- (d) Finalists and runners up will be notified by email by a representative of CAPIM.
- (e) CAPIM will publish the photos of finalists and runners up on CAPIM website.
- (f) Each winner will receive a \$100 e-gift card. Each runner up will receive \$50 e-gift card sent to the nominated email address on the entry form.

3. Copyright and moral rights

- (a) By entering the competition, you grant CAPIM an irrevocable worldwide licence to reproduce, publish, and communicate to the public your photograph (or any part of it) in any media format, including but not limited to websites, newsletters, social media, publications and reports.
- (b) By entering the competition, you warrant that you are the owner of all intellectual property rights in the photograph or have obtained all necessary approvals and consents to permit the entry of the photograph into the Competition and for use of the photograph in accordance with these terms and conditions.
- (c) Photography that infringes intellectual property rights of any person will be immediately removed from the Competition and you must return to CAPIM any remuneration or prize money paid to you by CAPIM.
- (d) CAPIM will use its best endeavours to acknowledge you in all Competition publicity as the creator of the photograph.

4. Release and indemnity

- (a) You release CAPIM from any claim, damage, expense, loss, cost or liability with respect to the infringement of your moral rights in respect of your photograph and the use of your photograph by CAPIM.
- (b) You agree to indemnify CAPIM against any claim, damage, expense, loss, cost (including reasonable legal costs) or liability (including liabilities of CAPIM to third parties) arising out of or in connection with infringement of any intellectual property rights in respect of your photograph; use of your photograph by CAPIM; and the Competition.
